## Notice of Annual General Meeting

Notice is given that the Annual General Meeting of shareholders of Cradle Resources Limited (**Company**) will be held at Level 7, 1008 Hay Street, Perth, Western Australia on Thursday, 21 November 2019 commencing at 3:00pm (WST) (**Meeting**).

### 1. Financial Statements and Reports

To receive and consider the Financial Report of the Company and the reports of the Directors and the auditor for the year ended 30 June 2019.

### 2. Resolution 1 – Re-election of Mr Grant Davey

To consider and, if thought fit, to pass the following as an **ordinary resolution**:

*"That, Mr Grant Davey, who retires as a Director of the Company in accordance with the Company's Constitution, be re-elected as a Director of the Company."*

### 3. Resolution 2 – Election of Mr Chris Bath

To consider and, if thought fit, to pass the following as an **ordinary resolution**:

*"That Mr Chris Bath, who retires as a Director in accordance with the Company's Constitution, be elected as a Director of the Company."*

### 4. Resolution 3 – Remuneration Report

To consider and, if thought fit, to pass the following as a **non-binding resolution**:

*"That the Company's Remuneration Report for the year ended 30 June 2019 be adopted."*

Note: The vote on this resolution is advisory only and does not bind the Directors or the Company.

### Voting Exclusion applicable to Resolution 3

In accordance with the Corporations act 2001 (Cth), the Company will disregard any votes cast on Resolution 3:

- a) by or on behalf of a member of the Key Management Personnel (KMP) whose remuneration details are included in the Remuneration Report, or a Closely Related Party of such member, regardless of the capacity in which the vote is cast; or
- b) by a person appointed as a proxy, where that person is either a member of the KMP or a Closely Related Party of such member.

However, a vote may be cast by such persons if the vote is not cast on behalf of a person who is excluded from voting on this Resolution, and:

- a) the person is appointed as a proxy that specifies the way the proxy is to vote on this Resolution; or
- b) the person is the Chairperson and the appointment of the Chairperson as proxy does not specify the way the proxy is to vote on this Resolution, but expressly authorises the Chairperson to exercise the proxy even if this Resolution is connected with the remuneration of a member of the Key Management Personnel.

## Voting and Attendance Information

### Right to vote

The Board has determined that persons who are registered as Shareholders as at 4:00pm (Perth time) on Tuesday, 19 November 2019 will be entitled to attend and vote at the Meeting.

If more than one joint holder of Shares is present at the Meeting (whether personally or by proxy, attorney or representative) and tenders a vote, only the vote of the joint holder whose name appears first on the register will be counted.

### How to vote

#### *Voting in person*

To vote in person, attend the Annual General Meeting on the date at the place set out above.

If you attend the Meeting, please bring your personalised proxy form with you to assist with registration. If you do not bring your form with you, you will still be able to attend the Meeting but you will need to verify your identity.

#### *Voting by proxy*

If you are a Shareholder entitled to attend and vote at the Meeting, you may appoint an individual or a body corporate as a proxy. A personalised Proxy Form accompanies this Notice of Meeting. A proxy need not be a Shareholder.

If a body corporate is appointed as a proxy, that body corporate must ensure that it appoints a corporate representative in accordance with section 250D of the Corporations Act to exercise its powers as proxy at the Meeting.

A Shareholder may appoint up to two proxies and specify the proportion or number of votes each proxy may exercise. If the Shareholder does not specify the proportion or number of votes to be exercised, each proxy may exercise half of the Shareholder's votes.

The Corporations Act provides that if proxy holders vote, they must cast all directed proxies as directed, and any directed proxies which are not voted will automatically default to the Chairman, who must vote the proxies as directed. If the proxy has two or more appointments that specify different ways to vote on the resolution, the proxy must not vote on a show of hands.

To vote by proxy, the Proxy Form must be completed, signed and returned to the Share Registry in accordance with the methods set out below, so that it is received at least 48 hours before the Meeting (that is, by no later than 3pm (Perth time) on Tuesday, 19 November 2019 (Proxy Deadline):

### *Corporate representatives*

A body corporate that is a Shareholder, or that has been appointed as a proxy, is entitled to appoint a person to act as its representative at the Meeting. The appointment of the representative must comply with the requirements under section 250D of the Corporations Act. The representative should bring to the Meeting evidence of his or her appointment as the body corporate's representative, including any authority under which the appointment is signed.

## **Explanatory Notes**

### **Introduction**

These Explanatory Notes form part of the Notice of Meeting and provide information to Shareholders about the items of business to be considered at the Annual General Meeting.

The Directors recommend that Shareholders read these Explanatory Notes, together with the Notice of Meeting, in their entirety before deciding how to vote in respect of the Resolutions.

### **Ordinary Business**

#### **Financial Statements and Reports**

The Corporations Act 2001 (Cth) (Corporations Act) requires the Company to lay its financial report, the Directors' report and the Auditor's report for the last financial year before the Annual General Meeting.

The Annual Report for 2019, which includes the financial report, the Directors' report and the Auditor's report is available on the Company's website at [www.cradleresources.com.au/annual-reports/](http://www.cradleresources.com.au/annual-reports/).

No resolution is required for this item, but shareholders will be given a reasonable opportunity to ask questions and to make comments on the reports and the management of the Company.

The Company's auditor will also be present at the meeting and shareholders will be given the opportunity to ask the auditor questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies adopted by the Company and the independence of the auditor.

#### **Resolution 1: Re-Election of Mr Grant Davey**

In accordance with ASX Listing Rule 14.4 and Article 6.3(b) of the Constitution, a Director must not hold office (without re-election) past the third AGM following the director's appointment or 3 years, whichever is longer.

Article 6.3(c) of the Constitution requires that one third of the Directors must retire at each AGM (rounded down to the nearest whole number).

Article 6.3(f) of the Constitution provides that a Director who retires under Article 6.3(b) or Article 6.3(c) of the Constitution is eligible for re-election.

Resolution 1 provides that Mr Grant Davey retires by rotation and seeks re-election as a Director. Details of Mr Grant Davey's qualifications and experience are set out in the Annual Report.

Resolution 1 is an ordinary resolution.

The Chairperson intends to exercise all available proxies in favour of Resolution 1.

#### **Resolution 2: Re-Election of Mr Chris Bath**

Mr Chris Bath was appointed as a non-executive director on 8 July 2019. In accordance with ASX Listing Rule 14.4 and Article 6.3(j) of the Constitution, a Director appointed under Article 6.2(b) must retire at the next AGM and is eligible for re-election at that meeting.

Accordingly, Mr Chris Bath retires at the AGM and, being eligible, seeks election as a Director of the Company.

Resolution 2 is an ordinary resolution.

The Chairperson intends to exercise all available proxies in favour of Resolution 2.

#### **Resolution 3: Remuneration Report**

In accordance with section 250R(2) of the Corporations Act, the Company must put the Remuneration Report to the vote of Shareholders. The Directors' Report contains the Remuneration Report which sets out:

- a) the Company's remuneration policy; and
- b) the remuneration arrangements in place for the executive Directors, specified executives and non-executive Directors.

In accordance with section 250R(3) of the Corporations Act, Resolution 3 is advisory only and does not bind the Directors. If Resolution 3 is not passed, the Directors will not be required to alter any of the arrangements in the Remuneration Report.

Pursuant to the Corporations Act, Shareholders will have the opportunity to remove the whole Board except the Managing Director if the Remuneration Report receives a 'no' vote of 25% or more (**Strike**) at two consecutive AGMs.

The Chairperson will allow a reasonable opportunity for Shareholders as a whole to ask about or make comments on the Remuneration Report.

Resolution 3 is an ordinary Resolution.

The Chairperson intends to exercise all available proxies in favour of Resolution 3.

If the Chairperson is appointed as your proxy and you have not specified the way the Chairperson is to vote on Resolution 3, by signing and returning the Proxy Form, you are considered to have provided the Chairperson with an express authorisation for the Chairperson to vote the proxy in accordance with the Chairperson's intention, even though the Resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel.

## Schedule 1 - Definitions

In the Notice and this Explanatory Memorandum, words importing the singular include the plural and vice versa.

**AGM** means an annual general meeting of the Shareholders.

**Annual Report** means the Directors' Report, the Financial Report, and Auditor's Report, in respect to the year ended 30 June 2019.

**ASX** means the ASX Limited ABN 98 008 624 691 and where the context permits the Australian Securities Exchange operated by ASX Limited.

**Auditor** means the Company's auditor from time to time (being Ernst & Young as at the date of the Notice).

**Auditor's Report** means the Auditor's report on the Financial Report.

**Board** means the board of Directors of the Company.

**Chairperson** means the person appointed to chair the Meeting convened by the Notice.

**Closely Related Party** means in relation to a member of a Key Management Personnel:

- a) a spouse or child of the member; or
- b) has the meaning given in section 9 of the Corporations Act.

**Company** means Cradle Resources Limited ACN 149 637 016.

**Constitution** means the constitution of the Company as at the commencement of the Meeting.

**Corporations Act** means the *Corporations Act 2001* (Cth).

**Director** means a director of the Company.

**Directors' Report** means the annual directors' report prepared under chapter 2M of the Corporations Act for the Company and its controlled entities.

**Explanatory Memorandum** means this explanatory memorandum which forms part of the Notice.

**Financial Report** means the annual financial report prepared under Chapter 2M of the Corporations Act for the Company and its controlled entities.

**Key Management Personnel** means persons having authority and responsibility for planning, directing and controlling the activities of the Company, directly or indirectly, including any Director (whether executive or otherwise) of the Company.

**Listing Rules** means the listing rules of ASX.

**Meeting** has the meaning given to that term in the introductory paragraph of the Notice.

**Notice** means the notice of the Meeting and includes the agenda, Explanatory Memorandum and the Proxy Form.

**Proxy Form** means the proxy form enclosed with the Notice.

**Remuneration Report** means the remuneration report of the Company contained in the Directors' Report.

**Resolution** means a resolution proposed pursuant to the Notice. **Schedule** means a schedule to this Explanatory Memorandum. **Section** means a section of this Explanatory Memorandum.

**Share** means a fully paid ordinary share in the capital of the Company.

**Shareholder** means a registered holder of a Share.

**WST** means Australian Western Standard Time, being the time in Perth, Western Australia.
